Planning Permission was only given to the site on condition there was no question of any outdoor space adjoining 3 Nutley Terrace. The introduction of this entertaining space will in fact introduce the exact opposite - potential for noise and parties at the point nearest to 3 Nutley Terrace, some 10ft from my sitting room in Flats 2 and the master bedroom of Flat 6. Note this is sited at the point closest to 3 Nutley Terrace. Where are they?</p> <p>C Reduction glass skylights</p> <p>D New Windows facing 3 Nutley Terrace Absolute objection to any further windows on the E wall facing 3 Nutley Terrace. Note, despite planning enforcement NONE of the E windows have been replaced with frosted glass as required by planning permission (John Sheehy). Almos all the windows in the property have been changed during construction, making the rear very dangerous for the children in the playground, We insist bars are olaced on the rear windows as currently play is restricted</p> <p>E Increase to height of boundary wall with 3 Nutley Terrace We have constantly objected to the rise in the height of the wall, which s for the convenience of the developer and against the wishes of the residents (john Sheehy and Cllr Fulbrook again</p> <p>F Change to windows As above</p> <p>G Change from glazing to solid wall between the two houses</p> <p>We note the changes which are missing from this application but which have nevertheless taken place, and to which we object, and have objected constantly with the full support of Cllr Fulbrook as follows 1 The change in brick used from red to white, totally out of keeping with the street and not consistent with the illustrations provided</p>

Damage to the forestry behind the site, notably adjoining 3 Nutley Terrace,</p> <p>3 Apparent work to the pavement fronting 3 Nutley Terrace to repair damaged paving. this was conducted some 2 weeks ago. Some 12 of the York paving stones have been broken and simply patched - making a very unsightly piece of work.
