The current proposal lacks architectural merit and has been poorly considered within its surroundings. It will be detrimental to the neighbouring estate of Lissenden Gardens, and to the views for the approach from Dartmouth Park.
					1. The proposal for the new PHS Science labs and Studio, and the Activity Hall to be so close to Clevedon Mansions is totally unacceptable. This new layout is ill thought out for the effect it will have on Lissenden Mansions and Clevedon Mansions. The height and scale of the proposed building will have a negative effect on Clevedon Mansions being just 20 metres away from the rear of those flats. The existing block causes light and noise pollution up to 10 pm on most nights, including weekends. There is the intention to increase the communal use of the new facilities in the evenings and weekends 4-10 pm Mon-Fri, 10-6 pm Saturdays. This will have a direct negative impact on the residents of Clevedon and will be intolerable.
					2. The construction of the sixth form La Swap building on the historic greens in front of the school will obstruct the views of the beautiful existing brick facade from the Highgate Road. This will deny existing views by the public when approaching the Heath from Dartmouth Park. This is a major access route to the Heath and this view to the old school building is a significant asset to the neighbourhood. The scale and size of the buildings are excessive and will totally dominate the whole of the Highgate Road approach.
					3. I object to the proposed removal of more trees to make way for the Le Swap building. I have not seen any proposals to replant and add an adequate number of extra trees as a result.
					4. The Construction Management Plan proposes for HGV egress heading North up Highgate West Hill. This route is not suitable for HGV traffic; the road narrows to down to a single lane halfway up the hill and will result in traffic chaos and increased risk of accidents. The estimate of 10 HGVs per day seems very low; it is expected the actual number of site vehicles to be much higher.
					5. The Construction Management Plan makes no specific reference as to how bicycle access and HGVs will be managed or separated. Given this is a school it is expected there is significant use of bicycles so it essential the access and egress of HGVs and other site traffic is carefully considered to avoid a serious accident.
					6. I object to the proposed Saturday site start time of 8am referred in the Construction Management Plan. The Lissenden Gardens estate in particular is a very quiet residential square; construction work noise at 8am on a Saturday for the next 3 years is completely unacceptable. Please reconsider this.

This boundary between buildings and the road is a core characteristic that defines Dartmouth Park and Parliament Hill. A building here severely diminishes the existing character and unique spatial characteristics of the area. The proposal to "green" the building has no substantial value as a proposal. The idea that by dressing a building with "greenery" makes it's location and form acceptable is farcical. Retaing the set back frontage of the existing school and preserving the spatial integrety of the existing set back is essential. As chair of the Dartmouth Park Neighbrouhood Forum I should note that consultation over the last year on the broader local environment establishes that these green spaces are fundamental to what local residents like about the area and underpin its sense of place and identity. a building here would adversely affect this and set a irreparable precedent to building in this protected zone. The justification that this is a 6th form building and should have its own apparent entrance is not convincing. Building way finding and location if well planned can achieve the desired separation without building into such an essentially locally valuable space.
