Please accept this letter and its enclosures as formal notification in writing of one (calendar) month notice in advance, in accordance with Regulation 5 of the Electronic Communications Code (Conditions and Restrictions) Regulations 2003 as required by the Communications Act 2003. No fee is required for this notification.

Telefónica UK Ltd are Electronic Communications Code Operators by virtue of Section 106 of the Communications Act 2003. This provides the necessary legislative basis to operate an electronic communications network. Telefónica UK Ltd intend to utilise their permitted development rights as defined in Part 24 of Schedule 2 of the Town and Country Planning (General Permitted Development) Order, as amended. The proposals contained herein constitute permitted development under Class A of Part 24.

The proposal is to install electronic communications apparatus/development ancillary to radio equipment housing on behalf of Telefónica UK Ltd.

Description of Development:

- The proposed upgrade comprises the installation of 2no new Yagi antennas, 1no new cabinet and ancillary works thereto.

For the avoidance of doubt this letter does not constitute:

- An application for a determination as to whether the prior approval of the Authority will be required to siting and appearance; or
