Rear Garden  
3 x Mimosa - Approximately 7m. Reduce crown heights by 20-25%, reduce lateral and sublateral branches overhanging lawn area by 30%. Reduce remaining extraneous growth to balance, (not more than 20-30%). Remove dead wood and broken branches. Thin crowns by 20%. Reasons: To increase light levels, relieve some weight burden and help promote healthy crown structure.

Birch - Approximately 10m, Located in 66 Regents Park Road. Reduce lateral and sub lateral branches growing over and towards 55 Kingstown Street by approximately 20-25%. Thin crown density by approximately 20%. Reasons: To help curtail encroachment and increase light levels.

Pittosporum and Griselinia Hedge - Located in 68 Regents Park Road. reduce back to as near to the boundary as is practicable and reduce height by 1-1.5m to control size and encroachment and to tidy.
