This is a second letter from Kentish Town Road Action, further to our letter of 07.01.15, making an additional point of objection to the application by Foxtons to install floor to ceiling windows on the Kentish Town elevation and on the Patshull Road elevation of the shopfront.

180 Kentish Town Road is on Camden's Local List, described as "Mid 19th-century public house on corner of Kentish Town Road and Patshull Road. Fully rendered, with applied pilasters between windows at shopfront level, architraves with geometric corner motif and simple projecting cornice. Canted corner with window at first floor and blind window at second floor."

As the building is on the Local List we urge Camden to protect the façade building from the development applied for by Foxton's, and to refuse permission.

If officers recommend approval of this application, we are asking for it to go before the Development Committee.

I write to express my strongest objection to the proposal to open yet another estate agents in place of Annie's bar on the corner of Patshull road.. My reasons are as follows:-

- 1) I live in Lawford road and we are over run with Estate agents in this area. Less than a mile away in Parkway Foxton's al;ready has a very ugly glazed megastore. Should Annie's receive similar treatment which seems probable judging from the preparatory drawings, showing full height glazing in all eight bays from which unsightlylight is bound to spill onto the pavements, it would completely destroy the nature of the original building.
- 2) Parking is already a problem in Patshull road and Bartholomew Villas.and any addition of Foxton cars taking up precious residents parking permits is completely unacceptable.
- 3) We are a vital community and we need a building which serves and enhances this community. Too many pubs have already been lost and a much valued newsagent plus Bird and Davis, a well renowned art shop, have been forced to close or move out because of Camden's spiralling rents.
- 4) London is fast losing it's soul and with it's absurdly inflated and escalating house prices is. becoming a capital only for the very rich, forcing those born and bred here to move out. The introduction of Foxton's on the corner of this residential area is a prime example and will be a constant reminder of this fact. I urge the application be refused and the building returned for the benefit of the local community.

Dear Mr Luxton,

I am writing to oppose in the strongest terms the planning application submitted recently by Foxtons' estate agents to convert Annie's pub building into yet another estate agent. I oppose this application on the following grounds:

- 1. That this building would be permanently lost to community use and turned over to commercial gain. This building, on the corner of a residential street, should continue to have a purpose as somewhere that offers a service to the community (as pub, cafe, restaurant, newsagent, etc, etc). I strongly support the building being added to the register as an asset of community value and I understand that the BARA community group has recently nominated it as such.
- 2. That this building has important townscape value (as is, of course, acknowledged by it being included on the list as a non-designad heritage asset). This would be diminished by day and by night if the current scheme succeeds 10 plate-glass windows would be inserted into the walls facing both onto Kentish Town Road and onto Patshull Road, prominent advertising would be added and a coloured glow which already bleeds into the surrounding area of other Foxtons would start to pollute the nightscape of this conservation area (which has, until Annie's closed, been lit by appropriate pub down-lighters).
- 3. Kentish Town Road really does not need another estate agent! Especially one already which has a landmark branch ten minutes walk away.

I do hope that you will take into account the enormous strength of community feeling that exists in opposition to this change of use.

Dear Neil Luxton,

I have learned that Foxtons made an application to move in the premises now known as Hoot 'n' Annie's, 180 Kentish Town Road, NW5 2AE.

In my view Foxtons moving in will in no way [concluding remark 5.4 of the planning statement] "have a positive effect on the local area and it will be a welcome refurbishment to the shopfront and the host building".

I assume I cannot object to the transformation of a pub into an estate agent – the former having a definite positive effect on the local area as pubs are not just a place to have a drink but places to meet and socialise for a community that finds itself increasingly fragmented by modern life; of estate agents we need far fewer, especially on Kentish Town Road where 9 already vie for business!

But I definitely wish to object to the application by Foxtons to install floor-to-ceiling windows on the Kentish Town elevation and on the Patshull Road elevation of the building. This would make bright and horrid light spill on to the high street from 3 windows but also on Patshull Road – form 5 windows. Furthermore these windows are completely out of character with the design of the upstairs storeys and facing the wonderful and iconic Grade II-listed 1930s London arcade shopfront that is Blustons across the road. True, there may not be great architectural unity in this part of town but an "improvement on the appearance and character of the host building" or the host street, this would not be. Kentish Town is changing. Several small businesses closed down in the past year. Thankfully we've also had a host of small independent coffee shops and eateries opening recently, but the "sleek" facade Foxtons is promising, as replicated dozens of times elsewhere, is totally devoid of character and not what this area needs.

Lastly with Foxtons would come an army of Mini Cooper cars as every agent of their usually large team is given one. Where would they park, if not in the residential area of Patshull Rd / Bartholomew Rd and Villas, where there does not seem to be the necessary space?
