2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24and DP25 of the London Borough of Camden Local Development Framework Development Policies.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: OS plan (65501), Comfort cooling and aerial system details, pipe kit details, mini heat pump specifications, 10465/PL2-ex rear elevation, 10465/PL2-ex front elevation roof plan and sections, 10465/CC2 /T1, 10465/CC5, 10465/CC6, 10465/PL1/2 A proposed front elevation, 10465/CC3 T1 basement floor plan, 10465/PL2/2 A proposed rear elevation, Noise Impact Assessment.

Reason: For the avoidance of doubt and in the interest of proper planning.
