#### **ENFORCEMENT NOTICE**

OF 207 High Holborn London WC1V 7BW

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: 207 High Holborn, London WC1V 7BW as shown, for the purposes of identification only, outlined in black on the attached plan.

# 3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The installation of a roof terrace, with associated decking, balustrade and staircase at roof level.

#### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The roof terrace, and associated balustrade and staircase constructed at roof level by reason of their design and location are considered to harm the special architectural interest of this grade II listed building which is considered to be detrimental to the character and appearance of the host building, and the Bloomsbury conservation area, and is detrimental to existing amenity by virtue of unacceptable overlooking and the loss of privacy in respect to the surrounding properties located in High Holborn and Newton Street

contrary to policies CS14 of the Local Development Framework Core Strategy, and policies DP24 and DP25 of the Local Development Framework Development Plan Document 2010.

c) The roof terrace by virtue of its would result in overlooking into the surrounding properties in and the loss of privacy and is considered to be detrimental to existing amenity contrary to policies CS5 of the Local Development Framework Core Strategy, and policies DP26 of the Local Development Framework Development Plan Document 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

#### 5. WHAT YOU ARE REQUIRED TO DO

Within a period of **two months** of the Notice taking effect:

- (1) Total removal of the timber decking, and associated balustrade and timber staircase at roof level; and
- (2) Make the development comply with the approved drawings of planning permission referenced 2008/1308/P dated 2 September 2008.

#### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **24 March 2015** unless an appeal is made against it beforehand.


