T4 = ORNAMENTAL PEAR - Crown reduce in height by 1-2 metres and shape remainder of crown to balance.  
T5 = ORNAMENTAL BAY - Crown reduce in height by 3-4 metres and shape remainder of crown to balance.  
T6 = ORNAMENTAL PEAR - Crown reduce in height by 1-2 metres and shape remainder of crown to balance, cutting back from property to give 2 metres clearance.  
SIDE ELEVATION with Frogna Lane:  
T7 - T9 = 3 x ORNAMENTAL THORN - Crown lift to 3 metres all round and clean through crown removing deadwood.  
T10 = ORNAMENTAL PEAR - Crown lift to 3 metres. Crown reduce in height by 2-3 metres and shape remainder of crown to balance, cutting back from property to give 2 metres clearance.  
T11 = ORNAMENTAL PEAR - Crown lift to 3 metres. Crown reduce in height by 2-3 metres and shape remainder of crown to balance, cutting back from property to give 2 metres clearance.  
T12 = SMALL BIRCH - Crown lift to 3 metres, reshape and tidy up.  
T13 = MEDIUM BIRCH - Crown lift to 3 metres, reshape and tidy up.  
T14 & T15 = 2 x FALSE ACACIA - Crown reduce in height by 2-3 metres and shape remainder of crown to balance.  
T16 = LARGE BIRCH - Crown reduce in height by 2-3 metres and shape remainder of crown to balance.
