#### **ENFORCEMENT NOTICE**

OF 1 Tasker Road London NW3 2YR

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: 1 Tasker Road, London, NW3 2YR

as shown, for the purposes of identification only, outlined in black on the attached plan.

## 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** The unauthorised replacement of 5 x timber sash windows with 5 x uPVC windows on the first floor front elevation.

#### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last **4 years**:
- b) The replacement uPVC windows due to their material and design have a detrimental impact on the character and appearance of the host building and the Parkhill and Upper Park Conservation Area. They are therefore contrary to London Borough of Camden Core Strategy policies CS14 (Promoting high quality places and conserving our heritage) and policies DP24 (Securing High Quality Design) and DP25 (Conserving Camden's Heritage) of the Local Development Framework 2010.

Council reference: EN12/0163

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

### 5. WHAT YOU ARE REQUIRED TO DO

The Notice shall require that, within a period of **6 months** of the Notice taking effect:

- 1) The 5x uPVC windows shall be removed and replaced with timber sash windows to match the existing front windows on the front elevation at ground and 2nd floor level
- 2) Make good any damage to the building as a result of the works.

Compliance due date: 19 March 2013

### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 19 September 2012 unless an appeal is made against it beforehand.

#### ANNEX YOUR RIGHT OF APPEAL


You can appeal against this notice, but any appeal must be received or posted in time to be received by the Secretary of State before 19 September 2012.

#### WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on 19 **September 2012**, and you must then ensure that the required steps for complying with it, for which you may held responsible, are taken within the period specified in the notice. Failure to comply with an enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
