Removal of Bullace/Damson tree and Birch tree to rear garden of No.3 Englands Lane directly adjacent to brick boundary wall, to prevent further damage to the wall, which is currently leaning with damaged masonry adjacent to the trees. No proposal to plant replacement trees in order to avoid repeat of damage to wall. Positions of trees are provided on the attached drawing 24202/001, on the existing wall elevation and plan.
