Re: Liddell Road – Overshadowing

The BRE guidelines acknowledge that sunlight in the space between buildings has an important effect on the overall appearance and ambience of a development. It states:

"...good site layout planning for daylight and sunlight should not limit itself to providing good natural light inside buildings. Sunlight in the space between buildings has an important effect on the overall appearance and ambience of a development."

The method for assessing sun on the ground is the 'sun-on-ground indicator'. The BRE Guidelines suggest that the Spring Equinox (March 21) is a suitable date for the assessment. Using specialist software, the path of the sun is tracked to determine where the sun would reach the ground and where it would not. This assessment reviews the total percentage of an area that receives at least 2 hours of direct sunlight on the March 21.

The guidelines suggest that for a garden or amenity area to appear adequately sunlit throughout the year, no more than half (50%) of the area should be prevented by buildings from receiving 2 hours of sunlight on the 21st March. They go on to say that an area of amenity space or garden may be adversely affected if less than half (50%) of the area is prevented by buildings from receiving 2 hours of sunlight on the 21st March does and the area which can receive some sun on the 21st March is less than 0.8 times its former value.

In respect to overshadowing caused by the proposed development at Liddell Road, London Borough of Camden have, in summary, requested that:-

"The impact of shading...on the adjacent Maygrove Peace Park, in particular the MUGA, outdoor gym and area of natural green space...should be undertaken and considered in determining the quality of the proposed open space provision...[and also to ensure that]...Maygrove Woodland Walk...will not be negatively impacted by the scheme."

We have not undertaken the sun-on-ground assessment for the five individual areas referred to above and highlighted in the attached plan. Instead we have undertaken a transient overshadowing analysis, which shows the path of the shadows cast by both the existing and the proposed buildings on

The side by side drawings attached show the times of the year and the duration of any additional shadow cast by the proposed development compared to the existing buildings.


These drawings clearly show that, whilst there will be some additional shadowing caused by the proposed buildings at various times and for differing durations during the year, the additional shadow is not sufficient to render any of the five areas of amenity space in a position where less than half (50%) of the area is prevented by buildings from receiving 2 hours of sunlight on 21st March.


All of the areas on the attached plan will, therefore, be adequately sunlit throughout the year.
