Dear Mr Markwell

I understand that there has been a public consultation about this stage of the development plans for Lawn Road. I have seen no notices and I have not been sent any notification in the last 3-4 months, nor have my neighbours, although I live in Upper Park Road. I have heard that very few people were notified. This is unacceptable as the development proposed has significant impact due to being much larger than the building presently there. Consultation is therefore vital.

Why was I, and probably the rest of the street/neighbourhood not alerted and consulted? How can I now be involved in the process to have my say?

- There are concerns about the high density of dwellings and the impact on demand for services and provision.
- There are concerns about the height of the block and its impact on local buildings and over-powering build.
- There are few affordable flats
- What about facilities for the Community Centre being replaced?
- What about replacing some of the workshops that were on site?
- What about the effect on parking pressure (notwithstanding that residents do not have a right to park)?
- What is the plan for the wonderful mosaic to remain in public view to brighten our day?

The decision on this need to go to committee and not be decided by delegated powers - there already has been a terrible curtailing of involvement in decision-making and comment on this.

I have been unable to identify the Head of Planning to make a complaint about the lack of consultation; how do I do so?
