Row of Chestnuts located opposite The White House:

1 x Chestnut - Approximately 4m. This tree has major decay and is unstable. Fell to ground level.

8 x Chestnuts - Approximately 4-6m. Re-pollard by means of removing all re-growth since last pruning to include removal of two elder saplings and chestnut suckers.

Row of thuja/conifer - Located in front of Chestnuts. Judiciously remove obvious dead branches from lowest crowns up to approximately 2.5m as is practicable without affecting viable green face of conifer hedge.

Reasons -To help the area to feel more airy and may allow for more light filtration
