The application seeks to create a rear extension to the lower ground floor that would house a new kitchen and living room space. In addition to the extension, the application seeks to convert the existing flat from a one-bedroom into a two-bedroom property. The extension will be a single-storey and intends to replicate those of nearby property extensions (Nos.80/ 84) that were granted planning approval (Ref: 2014/3987/P & 2014/3805/P). The rear extension will have a flat roof and finished in bitumen felt. Privacy screens are being specified at heights of 1800 and 1100mm around the flat roof to provide sufficient privacy to nearby neighbours. Construction will matching existing materials i.e. matching brick stock and bonding with white timber framed bi-fold doors.
