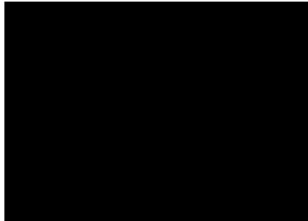

I am affected at my property at 2a Maryon Mews by the proposed construction work on 12 Maryon Mews as my external back wall butts against the proposed kitchen area (at present a conservatory) acting also as internal wall for house no. 12. In my view a new soundproofed wall would have to be constructed inside the planned kitchen area not using directly my external wall, meaning that my external wall would not be utilised in any direct form with any gap sound proofed. Measures would have to be taken to reduce noise and extract smells and fumes properly from the new kitchen area so as to cause the least possible inconvenience.

While I lament the prospect of upcoming disruption during the construction work, I must also deplore the planned alterations to No. 12 in the form of the erection of a two-storey rear extension to the house and infringements on the walkway as running contrary to the whole essence and spirit of Maryon Mews - an award winning building complex - as a closely knit community.

No 2A Maryon Mews, my property, is a mews cottage on the other side (facing South End Green) of the main complex, protected from change, and my rear wall, shared by the existing conservatory, must remain respected and untouched.
