Holm Oak - Located in 66 Redington Road. Approximately 8-10m. Judiciously reduce overhanging section by approximately 20% to control encroachment.  
Holm Oak - Located in 66 Redington Road. Approximately 12m. Reduce crown by approximately 20% to control encroachment.
