## DECISION

Town and Country Planning Act 1990 (as amended)

## Full Planning Permission Granted

Address: Flats 6 & 6A Maisemore Mansions 37 Canfield Gardens London NW6 3JN

Proposal:

Conversion of 2x flats at ground & basement level into 1 x 5 bed flat, including alteration of building fenestration, lowering of basement and associated landscaping works.

Drawing Nos: OS Plan, 5851-01, 5851-02, 5851-03 A, 5851-04, 5851-10, 5851-11, 5851-12 and Lifetime Homes.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and



Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: Conversion of 2x flats at ground & basement level into 1 x 5 bed flat, including alteration of building fenestration, lowering of basement and associated landscaping works.

Reason: For the avoidance of doubt and in the interest of proper planning.

4 The lifetime homes features and facilities, as indicated on the drawings and documents hereby approved shall be provided in their entirety prior to the first occupation of any of the new residential units.

Reason: To ensure that the internal layout of the building provides flexibility for the accessibility of future occupiers and their changing needs over time, in accordance with the requirements of policy CS6 of the London Borough of Camden Local Development Framework Core Strategy and policy DP6 of the London Borough of Camden Local Development Framework Development Policies.

5 Before the development commences, details of secure and covered cycle storage area for 1 cycle shall be submitted to and approved by the local planning authority. The approved facility shall thereafter be provided in its entirety prior to the first occupation of any of the new units, and permanently retained thereafter.

Reason: To ensure the development provides adequate cycle parking facilities in accordance with the requirements of policy CS11of the London Borough of Camden Local Development Framework Core Strategy and policy DP17of the London Borough of Camden Local Development Framework Development Policies.

1 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974.
