TREE: 1x Alianthus
Reduce and shape crown(s) by 20%, cutting back to a side branch and leaving a flowing branch line without stumps. Thin out crown by approximately 20% to produce an even density of foliage around a well spaced and balanced branch structure. Remove major dead and diseased wood from within crown. Remove basal/epicormic to crown break
