T1 Purple leaf Plum Prunus cerasifera 'Nigra' Rear right Mature, previously reduced tree. This tree is multi-stemmed, the main unions are compression fork unions with included bark. There is reaction wood forming under one of the unions which suggests that there has been movement in this union under mechanical loading. To reduce the mechanical loading, the suggested works are: To reduce back to the previous points of reduction, clean out crown, remove deadwood.
