<p>The tree has had lateral reduction work before. The limb @ 9m above ground on the Southeastern side is another likely candidate for failure. The limb has been reduced at approx. 6m out from the main stem and has approx. 4m of re-growth at the end with an average diameter of 15-20cm. The re-growth is very droopy and the limb itself has substantial reaction wood formation. The loss of the limb at 10m has exposed the remaining crown to wind loading and the overlong limbs and fragile nature of the timber is another failure that is waiting to happen. The suggested works are: To reduce the overall height by 3-3.5m and the lateral spread all round by 3-3.5m, remove deadwood and reduce lvy to approx. 1m below the crown break.</p>
