Existing Roof Plan

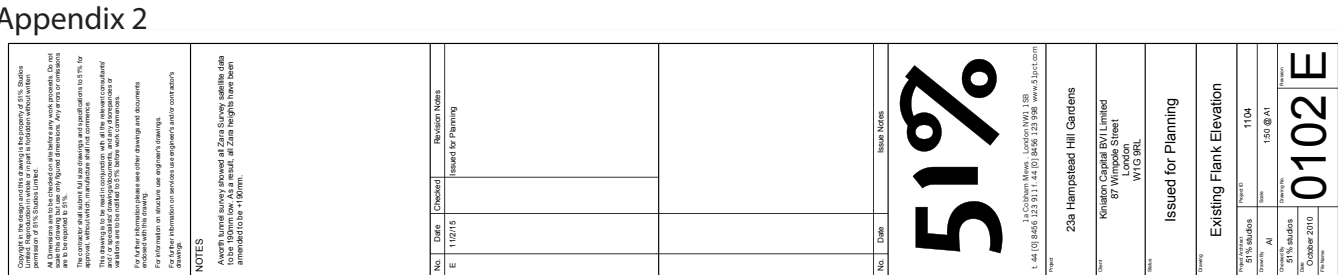

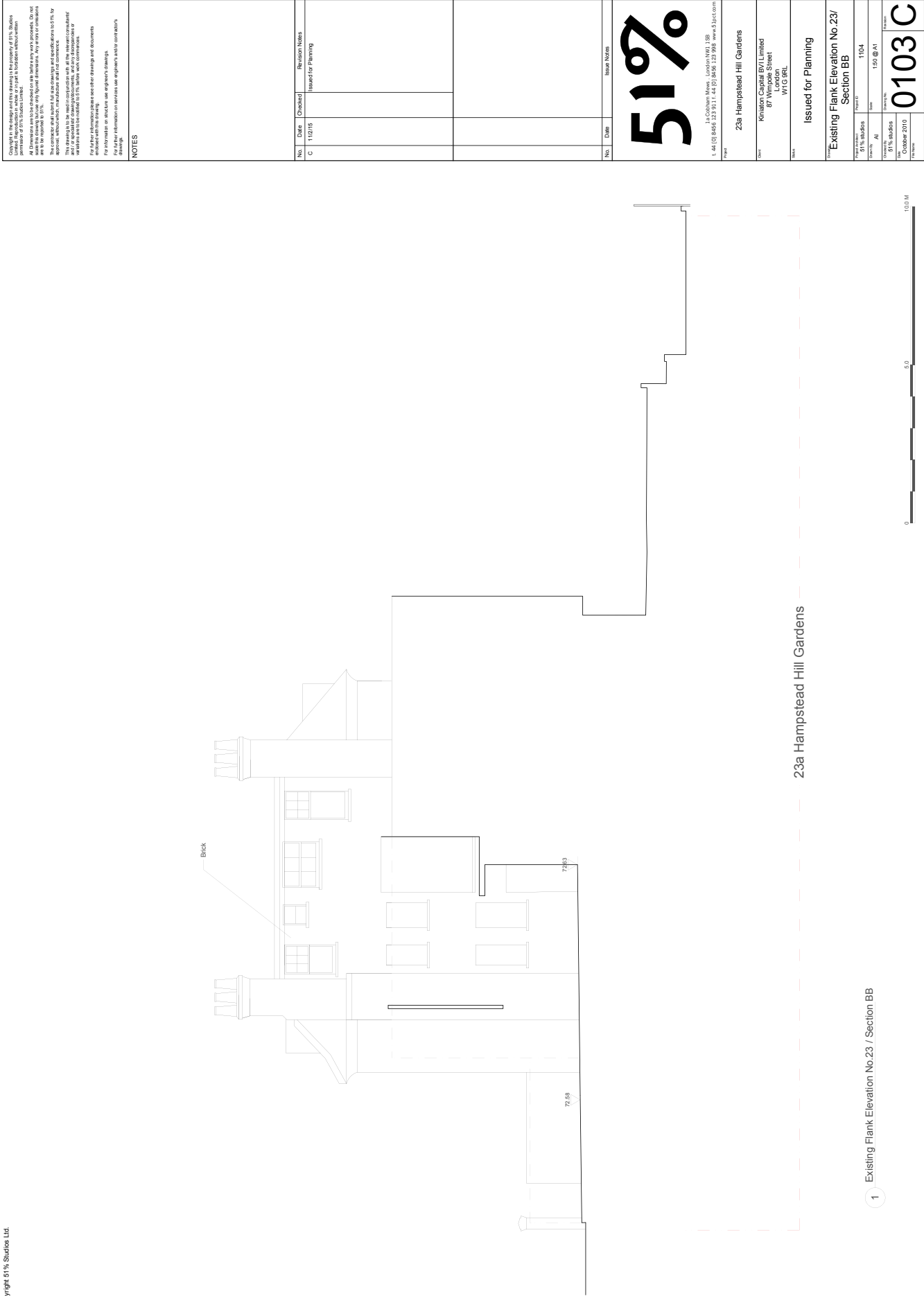


Existing Front Elevation

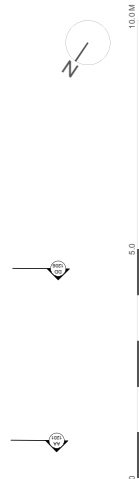


1 Existing Flank Elevation No.23 / Section BB

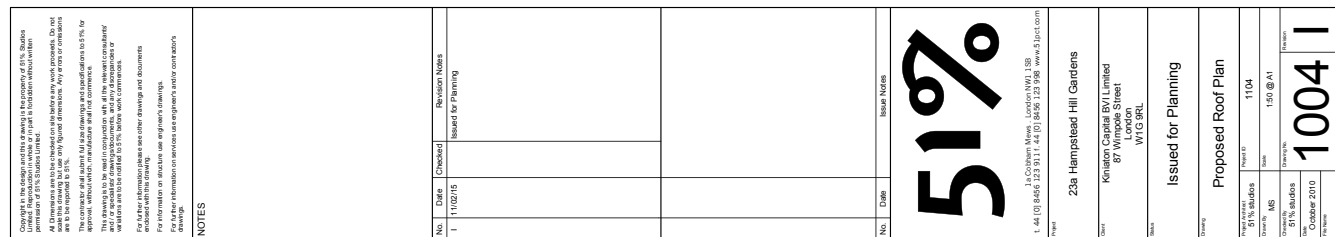

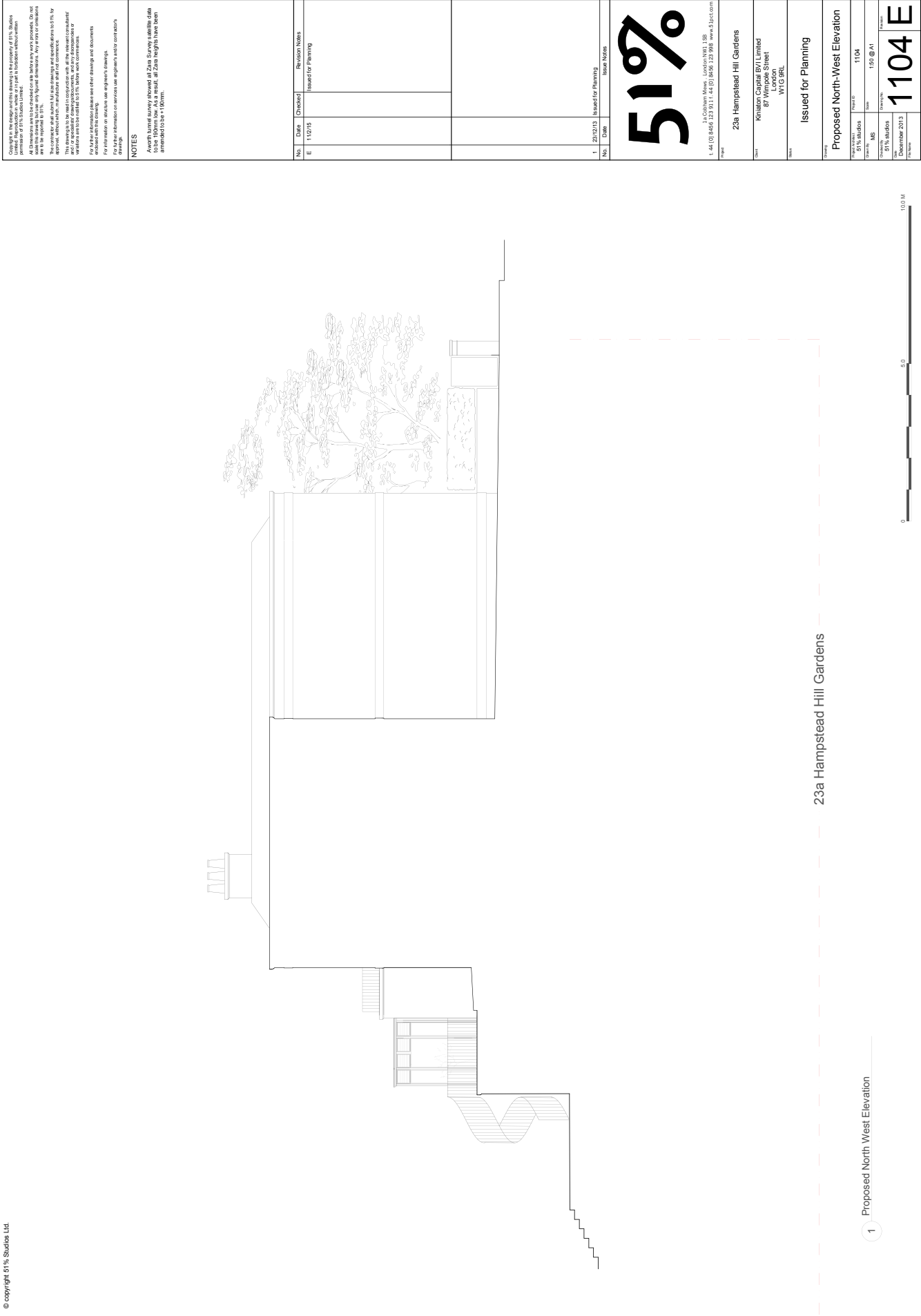

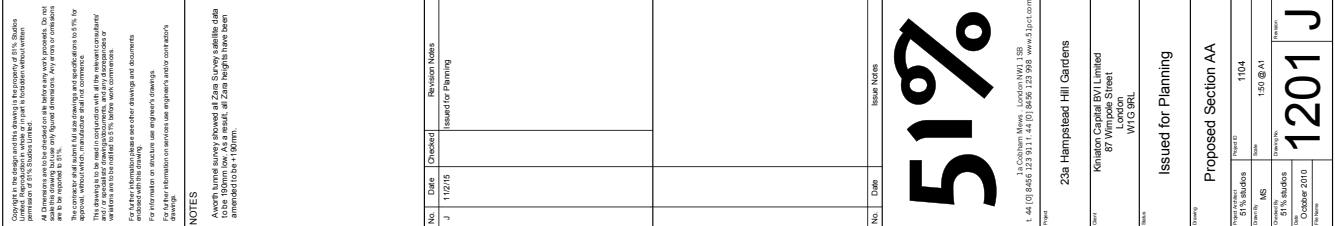
