FRONT GARDEN: T1 = CEONOTHUS - In decline - Fell as close as possible to ground level. G2 = PHOTINIA/ELDER etc Blocking light to property and obstructing pavement - Reduce in height by half and cut back to clear pavement. REAR GARDEN with side access: T3 = LARGE ASH - Branches overhanging roof, tree is close to the building and shrouded in ivy. We recommend: Cut back branches to clear building by up to 2 metres, sever ivy at base leaving 1 metre of clean stem at the base of tree. Allow remainder to die off for future inspections. Remove any ivy obstructing entry into the tree and clean through crown removing deadwood. NB - We recommend this tree be fully inspected once the ivy has died off.						

T4 = LARGE PEAR - Sever ivy at base leaving 1 metre of clear stem at the base and crown lift 3 metres. T5 = MATURE SYCAMORE - Located in the far corner of the garden - Sever ivy leaving 1 metre of clear stem at the base of the tree and clean through crown removing deadwood.

NB - As with T3 we recommend this tree be fully inspected once the ivy has died off. G6 = AREA OF JAPANESE KNOTWEED - Spray over area with systemic herbicide. NB - Repeat visit in 12 months time may well be required. This is not included in the cost of the quote.

G7 = NETTLES/BRAMBLES etc. - Strim over area and rake arisings into a compost heap in the far right-hand corner of the garden. G8 = GROUP OF SYCAMORES - Growing in adjacent garden, branches are overhanging into this garden - Cut back overhanging branches to boundary line.
