ENFORCEMENT NOTICE

OF 73 Mill Lane London NW6 1NB

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 73 Mill Lane, London NW6 1NB

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The installation of timber boarding to the shop window

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The timber boarding to the front elevation at ground floor level, by reason of its scale and design, completely obscures the original shopfront and is considered to be an incongruous addition which has a detrimental impact on the character and appearance of the host building, terrace and wider area contrary to policy DP24 (Securing high quality design) and Policy DP30 (Shopfronts) of Camden's LDF 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of three months of the Notice taking effect:

- 1. Remove unauthorised boarding from the shop window; and
- 2. Reinstate the shop window to match the original with a stall riser and two vertical timber glazing bars as show in appendix 1.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 23 April 2015 unless an appeal is made against it beforehand.



Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
