This would convert what has been a venue for discreet "adult" entertainment into one for up to 300 people in the 18-35 age group. Despite the best intentions, advanced research, and assurances of the promoters, this type of commercial enterprise has the inevitable consequence of increased disturbance, noise, and anti-social behaviour outside, even if the internal environment is well controlled. I am concerned about damage to parked cars, broken glass, and the general misconduct of departing "clubbers" in the early hours of the morning. The indication that there would not be more than 25 people queuing outside at any one time is not reassuring. The past experience from the now closed public house in the adjacent building, at number 317 Finchley Road, should serve as a reminder of how difficult it is to control the outside environment in this location. This is the wrong place for a night club as proposed.
