ENFORCEMENT NOTICE

OF 94 Camden Road London NW1 9EA

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 94 Camden Road, London NW1 9EA

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission:

The unauthorised installation of planters and decking to facilitate the use of the flat roof of the ground floor rear extension as a terrace; and

The unauthorised erection of timber support posts and timber housing erected to the rear of the ground floor rear extension.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The use of the flat roof as a terrace and other fittings associated with the terrace including the decking located on the roof of the ground floor rear extension and timber

enclosure structure at ground floor level by reason of its inappropriate location, size and scale would be an unsympathetic and incongruous addition, detrimental to the character and appearance of the host building and the conservation area, contrary to policy CS14 (promoting high quality places) of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

c) The roof terrace by reason of its position and proximity to neighbouring properties results in harmful overlooking into a rear habitable rooms at 84A, 84B and 211 and 209 and 209A Royal College Street and is thereby contrary to policy CS5 (Managing the impact of growth and development) of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 (Managing the impact of development on occupiers and neighbours) of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of one month of the Notice taking effect:

- 1) Cease the use of rear upper ground floor roof as a terrace;
- 2) Completely remove the planters and decking and make good any resulting damage;
- Completely remove the timber posts and boarding located at the rear of the ground floor rear extension; and
- 4) Remove from the land all associated materials and debris.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 30 April 2015 unless an appeal is made against it beforehand.


