Prune Pyracntha (ID# 4) located at the front of property according to the following specifications:

Prune Euonymus (ID# 6) located at the front of house front boundary according to the following specifications:

- Trim to maintain appearance of hedge.

Prune Hawthorn (ID# 2) located at the front of property according to the following specifications:

- Reduce crown height and spread by approximately 1.5-2 metres to enhance natural form.

Prune Elderberry (ID# 1) located at the front of property according to the following specifications:

- Reduce height and spread of tree to approximately 3 metres to begin the annual pollarding process.

Cut down the small self sown Elm x 4 (sukers) group (ID# 5) located at the front of house on mound. Leave stump as close as grade as possible and treat. Remove resulting debris.
