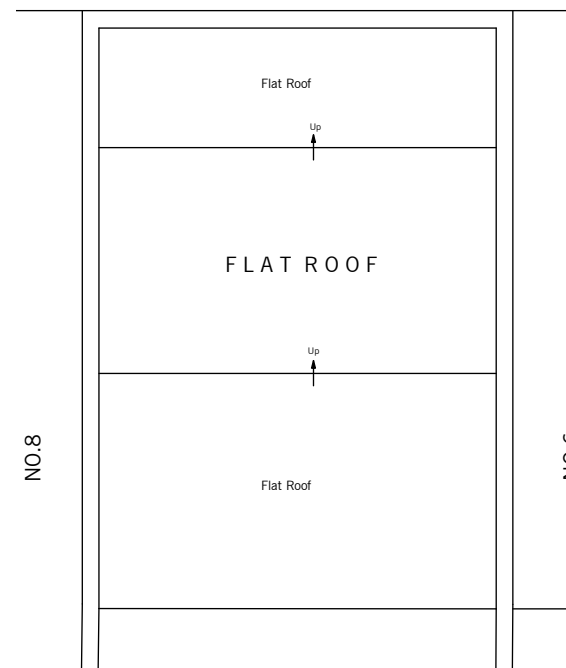

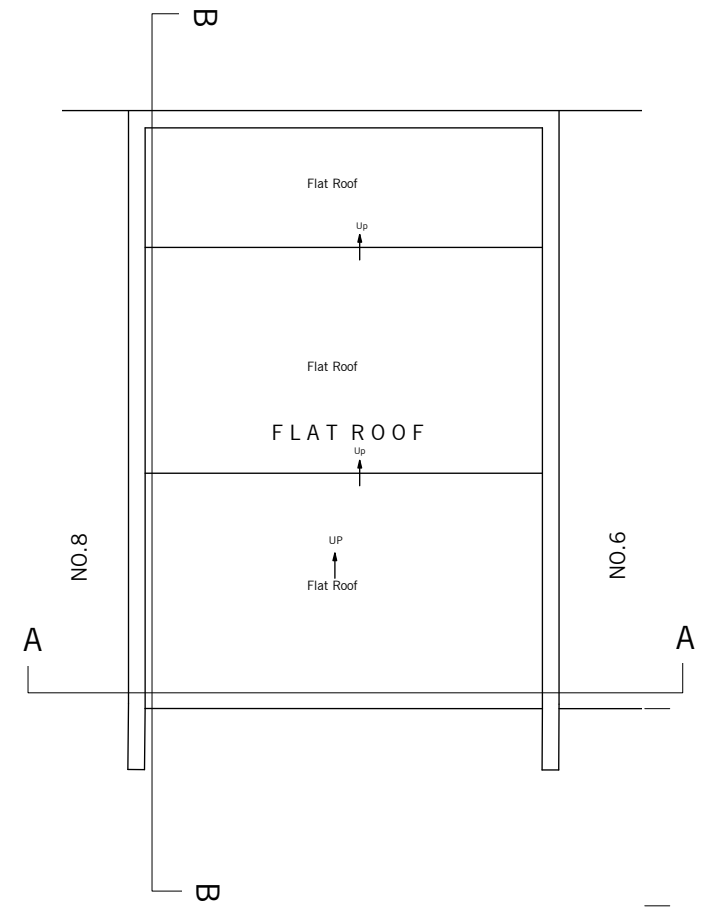
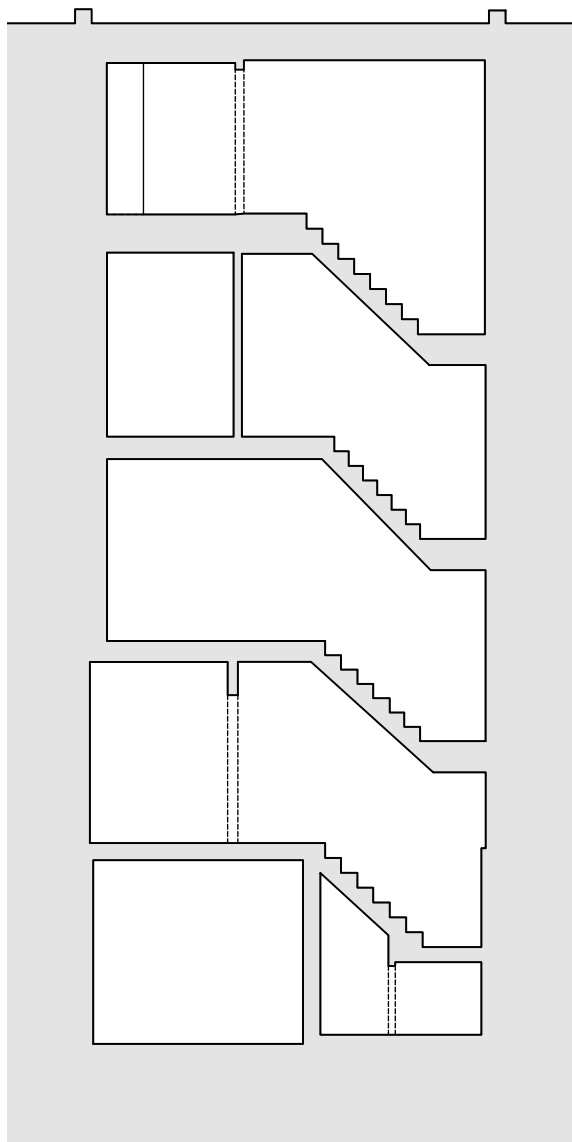
Fourth floor plan

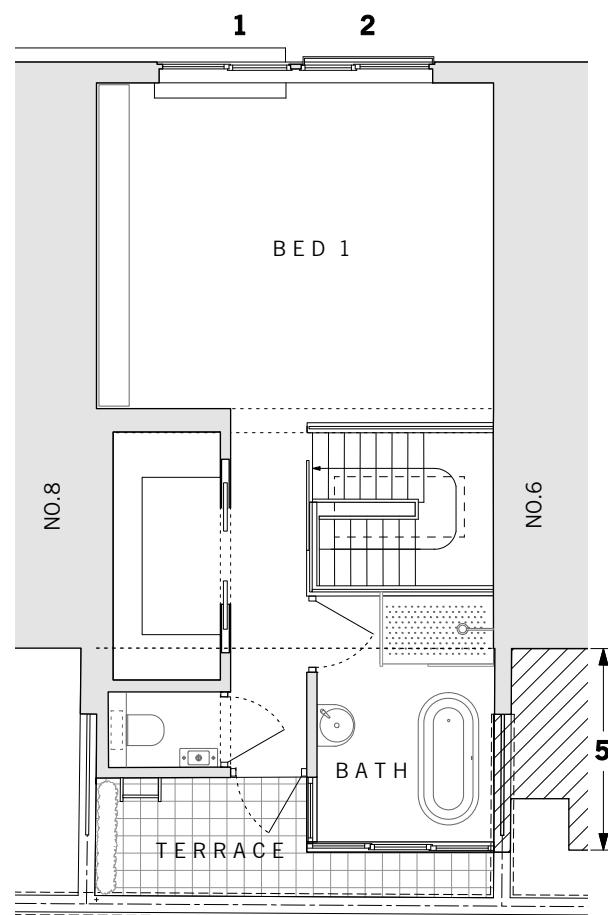
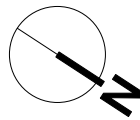


Example of varied cil height on rear elevation of Meadowbank terraces (view form Primrose Hill)

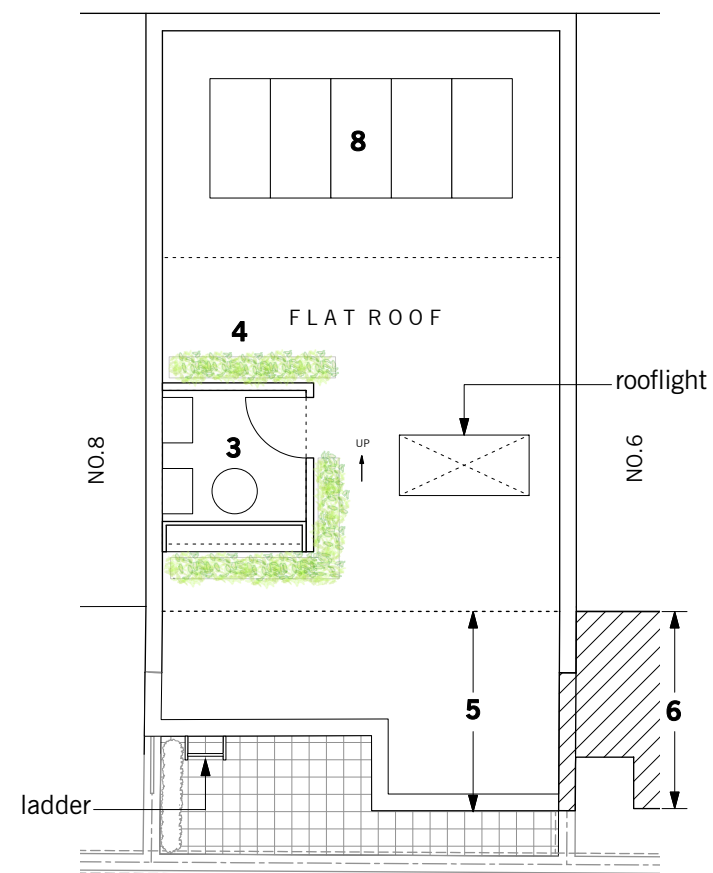


Example of varied cil height on rear elevation of Meadowbank terraces (view form Primrose Hill)

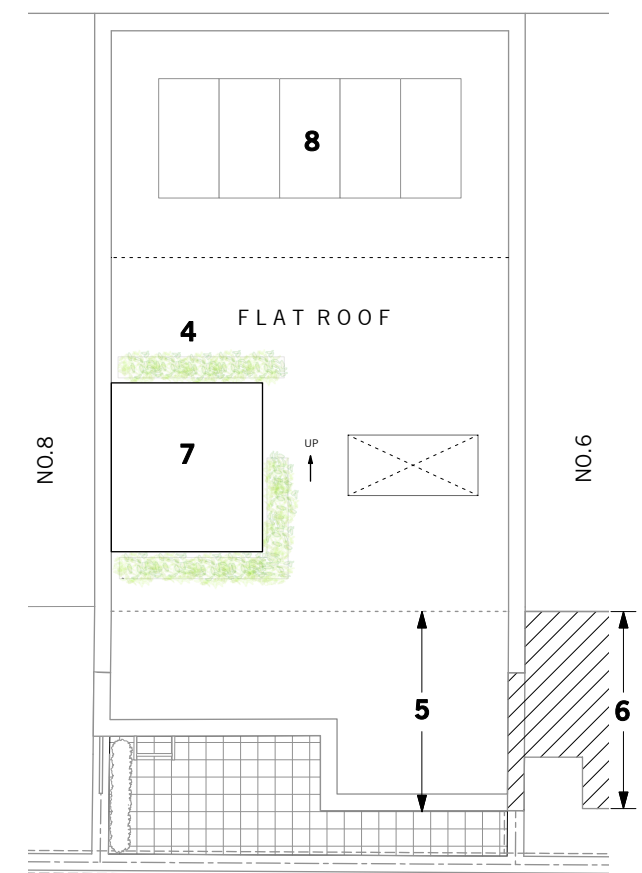




Fourth floor plan

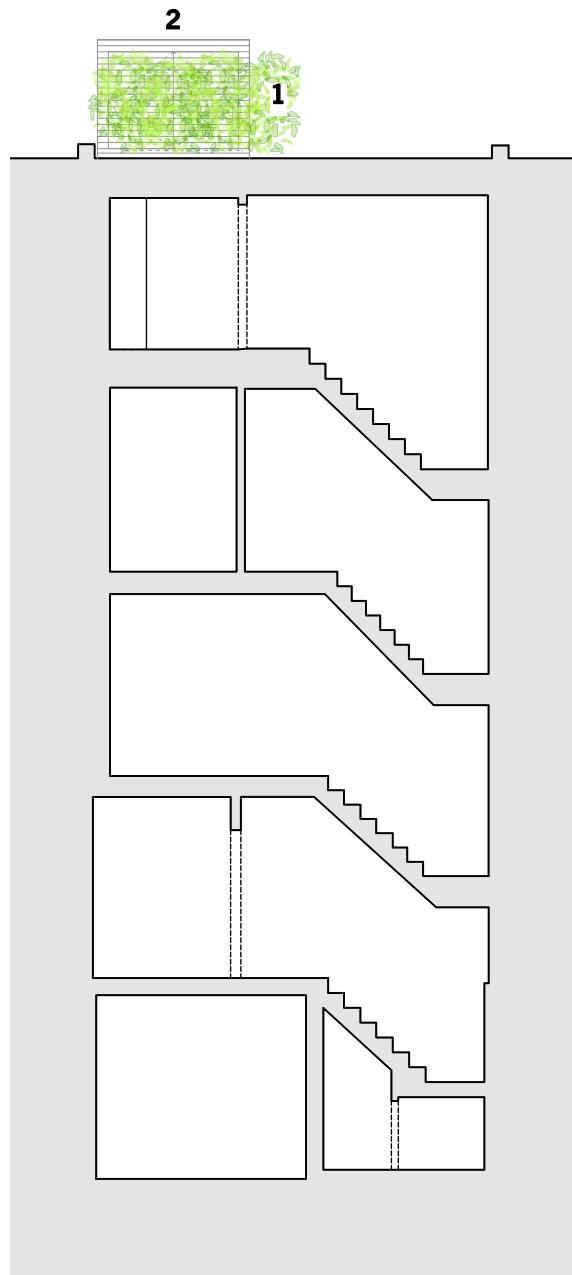

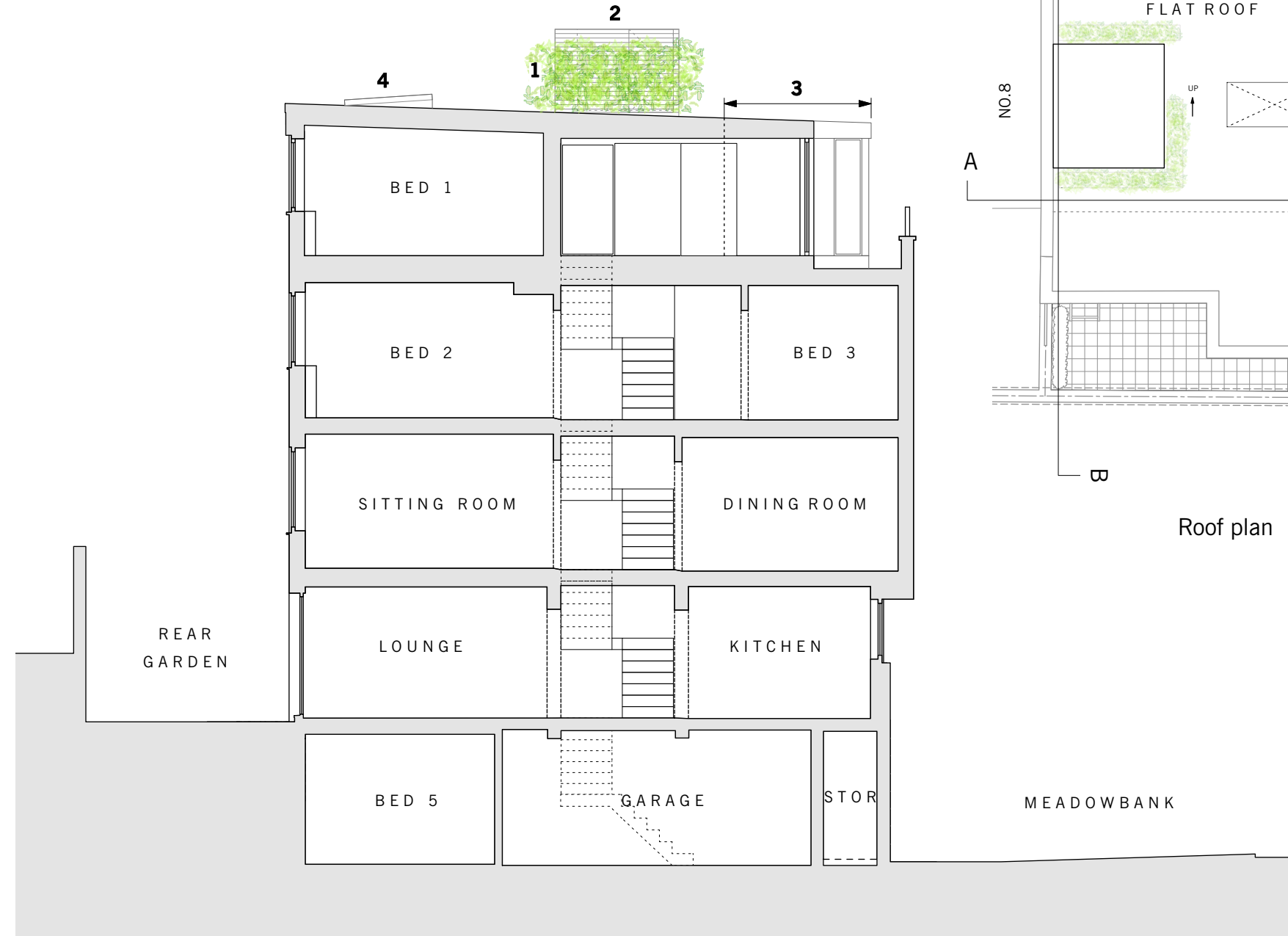
