Single glazed timber frame sash windows with timber shutterboxes. The shutterboxes and shutters are currently heavily painted and inoperable. The existing timber frame sliding sash windows are not original to the building and many are rotten or in otherwise poor condition and in need of thorough repair.

Single glazed, white painted, timber sliding sashes in repaired existing sash boxes. The restoration of the existing single glazed windows to all floors and installation of secondary glazing to basement and third floor has been approved in the previous applications (ref:2013/6717/P & 2013/6933/L).
