Hello Jenn,

Further to the below, I have discussed the proposals again with Michelle this morning. It appears that there are some discrepancies between the two documents issued by Derek Johnson on 9 March. The Roof Plan document identifies an access system consistent with what was discussed on site (i.e. an anchor and cable/harness system). However, the Materials and Workmanship Rev A document mentions the Versirail Freestanding safety guardrails system (on p68) which was previously proposed but ruled out following our site visit. Although we have now issued our authorisation for the application, this issue should be addressed and revisions submitted to remove any reference to the rail system if your Council is minded to approve the scheme.
