FRONT GARDEN
T7 = Large Conifer - The Client is concerned by the height of the tree as it sways heavily in the wind. It is our opinion that the tree is too tall for the location and a reduction in height would be advisable.
Reduce height by one third (33%)
REAR GARDEN - With no side access
G1 = Fig / Pyracantha – This tree is overlaying the Client's garden. For the adjacent garden, trim back as much overlay as possible to boundary line.
G2 = Clematis - Price down clematis to just above the spiral staircase (to be directed by the client)
T3 = Bay - Reduce height by 4ft. Trim sides to create a more narrow shape.
T4 = Large Conifer - No work required
G5 = Mixed Hedge - Lightly trim the top down to create a neater looking hedge
T6 = Apple - Heavily leaning - Remove the crown (to be directed by the client)
