- 6. Cherry – please specify how much you wish to thin and prune by – **15% thin and remove approx. 0.5 m all round**
- 12. Holly – Please can you clarify where the bay is and specify how much you wish to reduce – **there is an error on my list. I mean to leave the bay but reduce the holly by 2 metres in height**
- 28. Holly – please specify how much you wish to lift – **lift 2 metres over pathway**
- 30. Silver Birch – **reduce height by 1.5 metres.**
- 31. Laburnum – **reduce height by 1.5 metres and take 0.5 meters off lateral to leave in oval shape**
- 32. Holly – please specify how much you wish to reshape these three by. - **reduce height by 1.5 metres and take 0.5 meters off lateral to leave in oval shape**
