The Ground Floor will be used as an office by the Kosovan Embassy delegates, due to all day utilisation of the room by staff and service users creating an opening will significantly improve the well-being of staff and services users as it provides natural light throughout the day and cross ventilation. As a consequence the proposal makes property more efficient as it will reduce the need for artificial light and integrating passive cooling systems.

The proposal also aims to allow the building to "breathe" and control moisture and potentially minimises long-term decay problems to the fabric of the historic building.
