We wish to reduce the size of the tree situated at the back wall of the garden as it shades a large proportion of the garden. This has resulted in much of the grass dying and lawn turning to mud. REAR GARDEN: 1 x Plum - Reduce by 30% all round. FAR LEFT HAND CORNER: Mixed Species Group inc. Ash and Sycamore - Reduce by 30% all round. Cherry blossom reduced by 30%
