## Landscape Apecification Notes:

Tree planting 1no topsoil depth 900mm

Landscape contractor shall be required to brek up the base of the pit prior to planting and incorporate 0.25m3 of planting compost with the topsoil.

Tree underground guyed attaching to planter walls.

Shrub planting topsoil depth 500mm

Container grown shrubs shall conform to the BS3936 part 1. Shrubs to be minimum size specified in the schedules, plants should be rooted out.

1m3 of westland planting compost or similar approved to be mixed into the topsoil prior to planting.

## Mulch

50mm depth of westlands composted bark mulch or similar approved to be spread over planting beds after final rake and level.

Watering

Installation of Hose Lock'AC water timer pro & rain sensor' with 'Soaker Hose' and connections to each of the three beds.

## Maintenance

12 months from Practical Completion of works

All planting to be maintained in a healthy robust state.

All planting beds to be maintained weed free.

Flower beds to be chemical free only hand weeding.

All planting beds to be topped up with 25mm of composted bark on completion of 12 month maintenance period.

Herbaceous planting to be cut back as necessary between dec-mar.

Deciduous and evergreen cutting back as required.

Plant beds to be fed twice during first year.
