Following the withdrawal of our initial application on 9th March 2006 I am pleased to submit, on behalf of our Client the American Church in London, a revised application detailing our proposals for the alteration and extension of the church noted above.

The revision incorporates the detailed recommendations received from the Borough following our initial application. The subsequent amendments include the following:

- The Conservation Area application has been omitted under direction of the Council.
- A Design & Access Statement has been submitted with the application.
- A Land Quality report has been submitted as requested by the Council's Contaminated Land department.
- An Environmental & Sustainability report has been submitted which includes BREEAM and EcoHomes pre-assessments and details the predicted energy consumption and subsequent proposed energy saving measures.
- The Green Travel Plan' has been revised in order to address concerns raised by the Council.
- Additional daylight / sunlight reports have been submitted with regards to the vacant nursery building lying beyond the site boundary to the north and the accommodation at basement level which the proposed nursery would use.
- Access to and the layout of the nursery accommodation has been enhanced via further consultation with the Council's Early Years department.
- The overall extent of the new church extension (facing Whitfield Gardens)
 has been reduced in length and height to maintain the open aspect of the
 park.
- The materiality of the façade facing the park has been revised in order to address issues relating to maintenance.
- The adjacent retail unit's height has been reduced to a consistent singlestorey level.
- The height and form of the adjacent residential unit has been revised to enhance its contextual relationship with the church and surrounding buildings.Cont..
- The proposed mix of residential units has been revised to offer a wider range of accommodation
