56 DAY NOTIFICATION PROCEDURE SET OUT UNDER THE TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT) (ENGLAND) ORDER 2015 (GPDO) SCHEDULE 2, PART 3, CLASS A (CHANGE OF USE)

On behalf of our clients, Kicking Horse Limited (the registered owner of the site) and Faucet Inn Ltd (the public house operator), we write in regard to the above-mentioned site and planning legislation introduced on 6 April 2015. It is the intention of our client to commence development under permitted development rights.

The above legislation sets out a 56 day notification procedure to allow a planning authority to check whether a public house has been nominated as an ACV. If the public house is not the subject of an ACV nomination, the Council should advise this by return written correspondence and confirm that the developer has a twelve month period to undertake development through the implementation of permitted development rights.

The above legislation requires that our client provides a written request to the Council to commence the 56 day notification period. The legislation requires the following details to be submitted as part of the written request:
