Crown Place, which has double yellow lines both sides, is increasingly being used for casual parking and unloading, particularly by the shops in Kentish Town Road (Bengal Lancer, PDSA etc) but also by casual shoppers. They block access to and exit from, the 4 houses off the cul de sac and this happens more than once on a daily basis. To get my car out I have to identify the owner of the vehicle and then wait for them to move it. Having done this, this morning, I went out and on my return there were 2 vehicles in the way. To let them out I have to reverse into the main road right by a busy bus stop and pedestrian crossing which is extremely dangerous.(not for the first time) I have asked the various drivers to pull right into the cul de sac so we can get by ( I do not want to be at loggerheads with my neighbours) and they say they get a ticket if they do that. What can be done about this? Could we put a barrier up at the entrance? Could there be an identified unloading bay on the High Street for them? Could they be given tickets wherever they park, as a deterrent? (it is all double yellow lines) Would CCTV be of any help? Thank you for your help with this.
