The scheme as shown in plan 2 would be the Council's preferred option as it is considered that this proposals would cause the least impact and would not be readily visible from the wider public realm. The proposal for a lightweight glazed conservatory and a small rear extension is considered to be acceptable in principle as they are considered to be subservient in terms of their relationship to the host building. As such it is considered that the proposal would serve to preserve and enhance the character and appearance of the host building and the Bartholomew Estate Conservation Area, subject to its detailed design and detailing.
