Large, mature, previously reduced tree. To maintain this tree and to reduce the mechanical loading on the main union, the suggested works are: To reduce back to the previous points of reduction, retain shortened furnishing growth for crown continuity, remove up to 50% of fine, internal growth, remove deadwood.
Rear, neighbours
T2 Eucalyptus spp x 1
This tree overhangs the conservatory at 16a Heath drive. The tree is in close proximity and it is getting smothered in ivy. This creates extra weight on the branches and increases the mechanical loading on the tree. Because of its proximity, the tree should be maintained to control its moisture uptake. The suggested works are: To reduce the overhanging branches back to the previous points of reduction, remove ivy
