External alterations to the raised ground floor, including a change from a green roof to a decked area, a reduction in size of rooflight and creation of a planter as privacy screen to the boundary with No. 29 St Mark's Crescent.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans PL00-001, PL00-010, PL20-010, PL00-099, PL00-100, PL00-101, PL00-102, PL00-103, PL00-200, PL00-201, PL00-300, PL00-301, PL20-099, PL20-100 Rev A, PL20-101, PL20-102, PL20-200, PL20-201, PL20-202, PL20-300, PL20-301, Design and Access Statement (2nd issue dated 10.4.15).

Reason: For the avoidance of doubt and in the interest of proper planning.

- 4 Details of the proposed planter box and plants on the roof terrace facing 29 St Marks Crescent, details of which shall incorporate a 1.8 metre high permanent privacy screen, shall be submitted to and approved in writing by the Council. The approved planter, plants and screen shall be implemented prior to commencement of use of the roof terrace and permanently retained as such thereafter.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policy CS5 of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 of the London Borough of Camden Local Development Framework Development Policies.

- 1 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 2 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Compliance and Enforcement team [Regulatory Services], Camden Town Hall, Argyle Street, WC1H 8EQ (Tel.
