Front left side

1 Horse Chestnut Very large mature widespreading tree: To contain spread, lessen weight on branch ends and pre-empt potential for limb shedding/make safe and to improve light and clearance all round:

Reduce main crown by 25-30% all round to suitable new growing points using rigging equipment and lowering ropes for safe and controlled takedown (tiled and glass roofs below!) Clean out crown, remove deadwood. Lift canopy all round by 1-2m and balance crown. Also: The very large, very heavy overlong low lateral limb over the road: To lessen weight sufficiently to make safe and pre-empt potential for failure: Remove lowest fork over road, reduce back main limb by 3-4m to suitable pollard knuckles.

Front right

2 Bay Very large mature and very dense tree very close to the front elevation of No 4. To contain spread and improve light to and clearance of the building and to

improve space all round. Reduce crown all round by 50% to suitable new growing points. Thin and clean out crown, remove deadwood, weak and suppressed branches and suckers. Remove all large basal sucker growth. Lift canopy all round by up to 2m and level off 'browse line'.
