The Council has considered your application and decided to grant permission subject to the following condition(s):

The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as



possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans Site Location Plan, 15/201/1, 15/201/2, 15/201/3

Reason:

For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission.

The application property is located on the eastern side of Burrard Road. It is not a listed building nor is it within a conservation area. The proposed development consists a side infill extension measuring 7.8m in depth, 3m in height with four rooflights. There is an existing rear extension at the adjoining property No. 26 to the north. The proposed side extension would infill the void adjacent to the existing rear return at ground floor level. The proposed extension will be brick with a felt roof, UPVC windows and doors. It is considered that the design and materials of the proposed side extension would respect the character and appearance of the host building and is in general compliance with the advice in CPG1. The side facing windows in the adjacent property, No. 22 is obscurely glazed. Therefore there would be no impact on daylight into the adjacent windows as a result of the proposed extension.

The planning history of the site has been taken into account when coming to this decision. No objections were received regarding the proposed extension prior to making this decision.

As such, the proposed development is in general accordance with policies CS5 and CS14 of the London Borough of Camden Local Development Framework Core Strategy, policies DP24 and DP26 of the London Borough of Camden Local Development Framework Development Policies and CPG1 and CPG6 of the Camden Planning Guidance 2011. The proposed development also accords with policies 7.4 and 7.6 of the London Plan 2011; and paragraphs 14, 17, 56 -66 of the National Planning Policy Framework.

Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Argyle Street WC1H 8EQ, (tel: 020-7974 6941).

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Noise and Licensing Enforcement Team, Camden Town Hall, Argyle Street, WC1H 8EQ (Tel.
