Prior Approval Application for the change of use or 254-256 Belsize Road from Class B1a office use to Class C3 residential in accordance with the Town and Country Planning (General Permitted Development) (Amendment) (England) Order 2013 to create 20 new residential flats.

Transport Statement:

The proposed development will have no adverse impact on the Transport and Highways as the proposed development will be car free and will provide dedicated secure sheltered cycle storage for residents.

Car Parking.

In accordance with previous approved General Permitted Development application ref 2014/1417/P and the provisions of the Section 106 Agreement, the proposed development will be car free, and prospective residents will not be entitled to Resident's Parking Permits, unless they are holders of a disabled persons badge issued in pursuant to Section 21 of the Chronically Sick and Disabled Persons Act 1970.

This policy will remain in perpetuity.

Cycle Provision

The proposed redevelopment or 254-256 Belsize Road will create 20 apartments and in accordance with the Mayor of London's Housing Supplementary Planning Guidance, London Plan Policy 6.9, there will be a total of 23 dedicated secure cycle spaces for residents and an additional 3No for visitors to the development.

These will be in a secure location either with the building or in the external rear courtyard with convenient access to the street with adequate lighting.
