The clients and designers have taken on board the comments raised:  
1. Transparency of the new scheme compared to the permitted existing umbrellas.  
a. The mesh has been altered in the following ways:  
i. The gauge of the mesh and colour of the mesh has been altered so that it is more transparent.  
ii. The larger side panels have been removed.  
b. I would also confirm that the metal structure is made up of a minimal 50mm bar and is not designed to be able to take any further weight than the awning and the existing lightweight mesh.  
2. In light of your concerns of further walling we would underline that the client does not wish to have it as an enclosed space as it is also a smoking area and this could be made clear as a condition and that if at any time now or in the future that the hotel wished this to be enclosed they would need to re-apply for planning and listed building consent.
