Large, mature, Ivy smothered tree. This tree has been reduced in the past. To maintain this and to maximise the light, the suggested works are: To reduce back to the previous points of reduction, remove deadwood.

Remove Ivy from the crown to approx. 2m below the crown break.

Rear, neighbours (Oakhill avenue)

T6 Sycamore x 1

Large, mature, Ivy smothered tree. This tree has been reduced in the past. To maintain this and to maximise the light, the suggested works are: To reduce back to the previous points of reduction, remove deadwood

Remove Ivy from the crown to approx. 2m below the crown break.
