FRONT GARDEN
T1 = Large Lime - Neighbours are complaining that the tree blocks light and that honeydew drips on to their driveway.
Option 1:
Remove one of the two main stems of the tree - The one closest to the house (see photo).
Remove the stem closest to the house originating from the fork approximately 1.5m up from the main stem junction (see photo).
NB: As discussed on site we would not recommend this course of action, as in the long term, the health of the tree will be diminished. In the short term there are also strong concerns over the balance and stability of the tree.
Option 2:
Reduce height of tree by approx 2m
Reduce spread of tree by approx 2-3m
Reshape & Tidy up.
REAR GARDEN - With side access
T2 = Laurel - Remove the left hand limb that extends over the shed (see photo).
T3 = Apple - Grown out of shape due to it being overshadowed by large tree that has now come down. Lightly prune to shape.
