T1 = Lime - Reduced around 2 years ago, remove regrowth formed since most recent reduction. Retain epicormic and low branches so they screen the property behind.
T2 = Lime - At a high height than T1. Reduce to 1m below former reduction points to bring more into line with T1 Sever it at base and allow to die off naturally
REAR GARDEN No.17 with Side Access
T3 = Sycamore - Damaging retaining wall - There is a 8 foot plus drop in ground level between No.17 and No.15 so may change to the retaining wall could be very dangerous. Reduce down overall by 6-7m
