Pod Food Ltd currently occupies the ground floor of the property 5-7 Tottenham Street. The cafe uses 3 condensers which are located on the adjacent flat roof of No's 9-11 Tottenham Street. The cold room condenser requires a sound attenuating enclosure, as the noise has been assessed to be above the regulated standards near residential properties. The proposed enclosure is a Virgo housing unit, which will decrease noise emissions by 10db. Other existing condensers on the roof were installed by the Yumchaa café (ground floor of Nos9-11 Tottenham Street) and the Good Vibes gym (basements of Nos 5-7 & 9-11 Tottenham Street) .
