Dear Mr Tulloch,
I would like to object to the proposed basement and sub-basement extensions to 11 Rosslyn Hill.

I am a composer and orchestrator for video games and the bulk of the live recording that I do is done at AIR studios.

AIR is a thriving business, providing employment not just for its many permanent employees and resident composers but also the large number of orchestral musicians and bands who use its facilities - not to mention the people required to

create, organise and use the music being recorded.

AIR (along with Abbey Road) is one of the premier film score recording studio outside of America and its main hall is used almost every week for this purpose.

The proposed works would require AIR to be closed for at least six months - the effect on the people working there and on the landscape of the recording industry in the UK would be extraordinary. The permanent staff would all need to find alternative employment and those with writing and mixing rooms would need to find alternative accommodation - the nature of lease agreements for these rooms would likely mean they would need to be absent for at least 12 months, further damaging AIR's income.

Additionally, by reducing the number of London's large recording studios by half, the availability of work for musicians is reduced by half. The arts is a vibrant and financially important part of London's (and the UK's) economy and closing AIR for six months would have a significant impact on it. Not only that, local business would be affected - restaurants, pubs, shops and hotels all benefit from the large numbers of people working at AIR studios who would no longer be around.

In short, the benefit to the applicants of the basement extension must surely be outweighed by the negative effect on the hundreds of people who will be affected by the temporary closure of AIR.

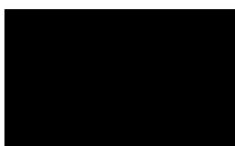

MPG represents the top producers and engineers working in the UK music industry and many of them use Air Studios on a regular basis.

Air Studios are only one of three remaining large recording

rooms left in London (in fact in the U.K.) that are capable of recording large orchestras, for them to be out of action for a protracted period would be disastrous for their long term business and catastrophic to the wider industry.

Many of the clients using the studio are from the film and TV business and come from all around the world specifically to use this facility but should it be out of action, there is no doubt that the sessions will go elsewhere and may not return. There are large numbers of other businesses involved in these productions and therefore there is a potentially huge knock on effect to income in many other parts of the industry.

Air Studios re-purposed this beautiful building at great expense and with a considerable amount of care and their business cannot be conducted anywhere else â the extent of the planning application you have before you is inappropriate and will cause disruption that cannot simply be compensated by financial means and we urge you to reject the unnecessary below ground development aspect of the plan.
