
Please also let me know if you would like me to forward your email to the Council's Highways team.

Dear Kate Phillips,

I'd like to complain that I was given no official letter with regard to this planning application for a roof terrace for my neighbour's flat overlooking my property. (One And A Half Woodchurch Road, NW6 3PL) 2015/2085/P

My neighbour, Mr Barson, asked my opinion earlier in the year if I had any objection and I had none. But I was not aware that it involved additional building. I thought it was a temporary measure whilst he was living there as my neighbour and that the terrace would then not necessarily be 'carried over' to whoever may be the next owner of the property.

Why wouldn't Camden council send me an official letter to the address most affected apart from Number 1? I have been away but was only made aware by an anonymous letter bringing my attention to the imminent planning being given.

Camden Council continues to disappoint me. My repeated emails concerning the blocked drain on the junction of Priory Road/ Woodchurch Road have been ignored for years. (Ref. 7314424/ Ref. 7332889 /Ref. 7314424 from 2011 / see attached letter from 2010)

It's a small public service on my part to make you aware of local issues. It's a shame you can't reciprocate the good manners.
